In reference to above cited letter, the Secretary, Department of Higher Education, U.P. Govt has forwarded the DO Letter of Govt. of India (jointly signed by Secretary Dept. of Higher Education and Secretary, Dept. of Social Justice and Empowerment), wherein directions were issued on formation of Anti-Drug Committees similar to Anti-Ragging Committees in Higher Education Institutions to ensure drug free campus.

Keeping in view above said directions, Hon'ble Vice Chancellor has constituted University level Anti-Drug Committee to ensure a drug free campus by imposing a total ban on the possession or consumption or use of drugs and alcohol by students of the University, within or outside the campus/hostel.

3. To engage the students in Anti-Drug activities and educate them about the ill-effects.
4. To prevent the initiation of drug use and the increase to addiction in those who have already initiated to use.
5. To encourage peer policing among students against the use of drugs and reporting of any noticed use of drugs by the students to the student's volunteers of Anti-Drugs committee.
6. The committee to ensure display of suitable hoardings/bill boards/banners in prominent places within the campus, to exhort the student not to indulge in drug consumption.
7. The committee shall conduct events like Anti-Drug workshop, seminars, orientation programs, counselling awareness programs educating ill effect of drugs sessions, encouraging peer policing among students against drugs and reporting of any noticed use of drugs by students to authorities.
8. The Committee shall intimate the local police, if anyone is found or reasonable believed to be indulging in consumption or possession or sale or purchase of Narcotic and Psychotropic drugs.
9. The committee shall meet once in every three month to discuss the various measures taken to ensure drug free campus. The minutes of meeting shall be submitted to V.Cs secretariat.
10. Disposal of the collected illicit material.

All Deans/HOIs/Principals/Directors/HODS/ are requested to form College level Anti-Drug Committees and follow the above guidelines.

Dean Students Welfare is requested to nominate three members of Students Council to University Anti-Drug Committee. HOD, Dept. of JMC is requested to nominate two members of NSS to the University Anti-Drug Committee. Nodal Officer-NCC is requested to nominate two members of NCC to the University Anti-Drug Committee.




