FEE STRUCTURE AND OTHER IMPORTANT TERMS AND
CONDITIONS FOR ADMISSION IN ACADEMIC SESSION 2017-18 IN
M.B.B.S. COURSE

Important Notes:

1. As per the judgment of the Hon'ble Supreme Court passed in the case of P.A. Inamdar, the State Government was authorized to make an interim fee fixation committee to fix the fee till any Act is made. The State Government has enacted Swami Vivekanand Subharti University Act in 2008 in which the right to fix fee has been given to the University. Thus, **the Swami Vivekanand Subharti University does not come under the purview of the Fee Fixation Committee of the Government for fixation of fee.** However, the committee has got the right to oversee whether any profiteering or commercialization of education is not being done.
2. In spite of the above mentioned factual position, the state Government issued notification no. 1083/71-2-16-37/2015 dated 07-04-17 through which it decided the fee structure of different PG courses of Subharti Medical College, Meerut, unilaterally. The College has filed a writ petition at the Hon'ble High Court. The hearing at the Hon'ble High Court will take place in due course of time and the Hon'ble Court will deliver the decision subsequently.
3. Similarly, the State Government has issued another notification no. 2008/71-2-17-37/2015 dated 09-06-2017 through which it intends to fix the fee of MBBS course also. The College has proposed Rs. 21 lacs and 45 thousand per year. In case, the fee is decided lesser than this amount by the State Government, the College and the University will have to file another Writ Petition at the Hon'ble High Court.
4. Since, the college does not want to come in confrontation with the Government because that will affect the students who are eager in taking admission at Subharti Medical College, Meerut, the College will accept the fee structure fixed by the State Government under protest. **However, the decision given by the Hon'ble Court shall be applicable on the College as well as on the students.**
5. **All the students aspiring to take admission in MBBS course at Subharti Medical College, Meerut are advised to go through the following regulations very carefully before filling the online form.**
 - (A) Full Fee will be deposited at the time of admission. No Part payment of Fee is permitted. If any amount has been deposited with the DGME, U.P. in the head of College fee, the remaining fee will have to be paid at the College in addition to fulfilling all the condition. The College will not be responsible if the student fails to fulfill any condition and the amount deposited with the DGME is confiscated by the DGME.
 - (B) Total fee will be required to be deposited before the LAST DATE declared by the Counseling Board.

- (C) The candidate will have to submit a Bank Guarantee from a Nationalized Bank of the fee of remaining three and a half years for MBBS course before the LAST DATE of admission as declared by the counseling board. This is in accordance with the judgment of the Hon'ble Supreme Court. **This condition can be relaxed in deserving cases on being applied to the Hon'ble V.C. of the University through the Principal Subharti Medical College, Meerut.**
3. The fee can be revised in view of the order of the Hon'ble Court or the Government.
 4. Refundable security deposit will be Rs. 5,00,000/-
 5. There will be miscellaneous charges of Rs. 1.00,000/- in addition to the Course fee.
 7. An additional tuition fee not exceeding 10% of the course fee and supplementary exam's fee for failed/detained students will be charged.
 8. Hostel is compulsory for all the students except for those whose parents are resident of Meerut or Modinagar.
 9. Hostel & Mess charges will be as follows:
 - (a) Rs. 1,05,000/- (Triple Seater-Non AC) per year for Girls. Window AC-optional- if available with additional charges.
 - (b) Rs. 1,25,000/- (Double Seater– Non AC) per year for Girls. Window AC-optional- if available with additional charges.
 - (c) Rs. 1,20,000/- (Triple Seater- Central AC) per year for Boys
 - (d) Rs. 2,00,000/- (Double Seater- Central AC) per year for Boys
 10. Refundable Hostel Security –Rs. 50,000/-.
 11. Fee once deposited is non-refundable.
