

**SUBHARTI MEDICAL COLLEGE, U.P.**  
**FEE STRUCTURE AND OTHER IMPORTANT TERMS AND**  
**CONDITIONS FOR ADMISSION IN ACADEMIC SESSION 2017-18 IN**  
**M.D., M.S. & PG DIPLOMA COURSES.**

**Important Notes:**

1. As per the judgment of the Hon'ble Supreme Court passed in the case of P.A. Inamdar, the State Government was authorized to make an interim fee fixation committee to fix the fee till any Act is made. The State Government has enacted Swami Vivekanand Subharti University Act in 2008 in which the right to fix fee has been given to the University. Thus, **the Swami Vivekanand Subharti University does not come under the purview of the Fee Fixation Committee of the Government for fixation of fee.** However, the committee has got the right to oversee whether any profiteering or commercialization of education is not being done.
2. In spite of the above mentioned factual position, the state Government has issued notification no. 1083/71-2-16-37/2015 dated 07-04-17 through which it has decided the fee structure of different PG courses of Subharti Medical College, Meerut, unilaterally. The move of the State Government is arbitrary and illegal, against which the College has filed a writ petition at the Hon'ble High Court. The hearing at the Hon'ble High Court will take place in due course of time and the Hon'ble Court will deliver the decision subsequently. **The decision given by the Hon'ble Court shall be applicable on the College as well as on the students.**
3. Since, the college does not want to come in confrontation with the Government because that will affect the students community which is eager in taking admission in PG courses at Subharti Medical College, Meerut, the College has accepted the fee structure fixed by the State Government under protest.
4. **All the aspirants for taking admission in PG course at Subharti Medical College, Meerut are advised to go through the following regulations very carefully before filling the online form.**
  - (A) Full Fee will be deposited at the time of admission. No Part payment of Fee is permitted.
  - (B) Total fee will be required to be deposited before the LAST DATE declared by the Counseling Board.
  - (C) The candidate will have to submit a Bank Guarantee from a Nationalized Bank of the fee of remaining two years for degree course (one year for the diploma course) before the LAST DATE of admission as declared by the counseling board. This is in accordance with the judgment of the Hon'ble Supreme Court. **This condition can be relaxed in deserving cases on being applied to the Hon'ble V.C. of the University through the Principal Subharti Medical College, Meerut.**
  - (D) General and important information:
    1. Course Fee of MD, MS & PG Diploma courses of different departments is as follows as per the Government notification:

3. The stipend is adjustable in fee on monthly basis in the subjects of Anatomy, Physiology, Biochemistry and Forensic Medicine however; TDS and interest will be levied.
4. The fee is only for the year 2017-18 and can be revised in view of the order of the court or the Government.
5. Refundable security deposit will be Rs. 2,00,000/- (Two Lacs Only) in Anatomy, Physiology, Biochemistry and Forensic Medicine.
6. Refundable security deposit will be Rs. 3,00,000/- (Three Lacs Only) in Microbiology, Pharmacology & Community Medicine

7. Refundable security deposit will be Rs. 5,00,000/- (Five Lacs Only) in Anesthesia (Degree & PG Diploma) & Pathology, Psychiatry and ENT.
8. Refundable security deposit will be Rs. 10,00,000/- (Ten Lacs Only) in Surgery, Pediatric, Ophthalmology, Respiratory Medicine and General Medicine.
9. Refundable security deposit will be Rs. 15,00,000/- (Fifteen Lacs Only) in Obstetrics & Gynecology, Orthopedics, Radiology & Dermatology

Note: The security fee has been decided keeping in mind, the cost of equipments, which will be used by the PG students in different departments and also other relevant factors.

10. An additional training, supplementary exam's fee for failed/detained students will be charged.
11. Stipend will be given to the PG students equal to the stipend given in Government Medical Colleges. It is relevant to mention that the fee shall also be increased in the same proportion as the increment made in the stipend from time to time.
12. Hostel is compulsory for the P.G. students of Clinical Departments where as it is not compulsory for the PG students of non-clinical and para-clinical departments except department of Forensic Medicine and Pathology.
13. Hostel & Mess charges will be extra which will be Rs. 2 lacs per year for Non-AC single accommodation with toilet whereas it will be 3 lacs per year for AC single accommodation with toilet.
14. Refundable Hostel Security – Rs. 50,000/-.
15. Fee once deposited is non refundable.
