

**REPORT ON ENQUIRY REGARDING ANONYMOUS COMPLAINT OF RAGGING IN SUBHARTI MEDICAL COLLEGE RECEIVED FROM UGC ANTI-RAGGING HELP LINE CELL**

1. An anonymous complaint alleging an incident of ragging in Subharti Medical College, a constituent college of Swami Vivekanand Subharti University, Meerut was forwarded by UGC Anti-Ragging Helpline Cell.
2. As per University Notification notified vide U-735/2025/911 dated 28.05.2025, a meeting of Anti-Ragging Committee of the University was called to investigate and discuss the complaint received from UGC Anti-ragging Helpline cell.
3. A meeting of the Anti-Ragging Committee of the Swami Vivekanand Subharti University, Meerut was held with Senior Official of District Administration, Local Police Official, Provosts /Chief Wardens/Senior Wardens of University Hostels, Heads and Deans of Departments, Chairman of Anti-Ragging Squad and Anti-Ragging Committee and Officials of University on 03.06.2025 AT 11:00 a.m. in the University Conference Hall of SVSU.


5. The following members have taken leave of absence and could not attend the meeting;

6. The Following Agenda Item were taken for deliberation and discussion;
- Agenda No. I:** Use of Abusive and Obscene remarks against Junior Batch of Medical Students by Senior Batch of Medical students.
  - Agenda No. II:** Ragging is rampant across almost all medical courses at the University. Senior batch students are indulging in mental harassment of junior batch students which includes use of vulgar abuses, obscene comments about family members, forcing juniors to do personal chores, issuing direct threats of physical assault if the orders of seniors are not followed.
7. Prof. (Dr.) Nitin Tyagi, Secretary, Anti-Ragging Committee and Chief Proctor placed following points before the committee;
- Receipt of complaint received from UGC Anti-ragging Helpline Cell brought to the Hon'ble Vice Chancellor, the Chairman of University Anti-Ragging Committee and Committee Members
  - A surprise inspection were conducted at Hostels common areas, classrooms and hospital by Anti-ragging Cell of Subharti Medical College on 28 & 29 May 2025
  - Confidential interviews conducted with randomly selected UG and PG students of Subharti Medical College from relevant batches of medical students.
  - Faculty, Warden, hospital Staff, Nursing Staff were consulted for behavioral feedback.
  - Complaint Box and helpline were also monitored for corroborating inputs
  - CCTV surveillance footages as per time stamps of the common, area, classroom, hostel premises were reviewed for any corroborating inputs.
  - Mobile messages received by junior students were also checked for any objectionable messages.
  - No Corroborating inputs / evidence could be established on reported complaint of Use of Abusive and Obscene remarks against Junior Batch of Medical Students by Senior Batch of Medical students or in mental harassment of junior batch students which includes use of vulgar abuses, obscene comments about family members, forcing juniors to do personal chores, issuing direct threats of physical assault if the orders of seniors
8. Prof.(Dr.) Vaibhav Goel Bhartiya, Chairman of university Anti-ragging Squad placed the following before the committee;
- The Anti-ragging Squad is constantly monitoring the activities of students with respect any ragging towards junior batch students.
  - University Anti-ragging squad did not receive any complaint of ragging in the university during the said period in the University
9. Gp. Capt M Yakoob, the Registrar of the University placed the following before the committee;

- a. Detailed Guidelines for prevention of ragging and other form of indiscipline has been sent Principals, Dean, Provosts and Head of Institutions and Departments, of university and also available on **SVSU** website
  - b. Setting of Joint Control Room in Proctor office to look into any complaint of ragging /eve-teasing etc. The setting up of Joint Control Room in Chief Proctors Office with effect from 25<sup>th</sup> July 2025 to 30<sup>th</sup> Sep 2025 (09:30 a.m. to 05:30 p.m. This will be manned by both Proctorial Team, Team formed under DSW.
  - c. Colleges /centers /Hostels have been requested to restrict the entry of outsiders, and to prominently display rules regarding prohibition of ragging.
  - d. The Hon'ble Supreme Court judgment on ragging would strictly be followed by all concerned. All students and their parents have been asked to give an undertaking to this effect.
  - e. Regular and unannounced inspection should be conducted to detect unauthorized entry / stay in hostels. No guest is to be allowed to stay in the hostels during initial weeks of reopening of the University in the new academic session
  - f. Sending appropriate communications to Law Enforcing Agencies to cooperate in keeping SVSU campus ragging free
  - g. The Act indiscipline and ragging will be dealt with strictly under the provisions of University ORDINANCE No. VII (6). The said ordinance gives legal authority to Principals, Heads, Provosts and Chief Warden to take preventive as well as punitive action, wherever required. Police assistant will be sought whenever situation warrants.
  - h. Instructions regarding regular patrolling will be carried out to monitor and prevent any incident of ragging both by Anti-Ragging Squad and Proctorial team of SVSU separately as well as jointly.
10. The committee deliberated and discussed in length on above said action initiated by Anti-Ragging Cell, Anti-ragging Squad and made following observation;
- a. There is no direct evidence or identification of victim or perpetrators
  - b. Students and Staff uniformly denied any incident of ragging in the Subharti Medical College.
  - c. No written complaint received through University Grievance Redressal Channels. Campus surveillance, Wardens and Hospital superintendent reports showed no unusual activities
  - d. No corroborating proof to validate the anonymous complaint.
  - e. University Anti-ragging squad did not receive any complaint of ragging in the university during the said period in the University.
  - f. The environment remains disciplined and supportive.
11. The Anti-Ragging Committee made following conclusion
- a) Based on the enquiry, no evidence of ragging or harassment has been found to substantiate the anonymous complaint.
  - b) The Committee acknowledges the all complaints of ragging including the anonymous complaints and reaffirms zero-tolerance policy towards any form of ragging
  - c) Fresh advisory being once again issued to all students reiterating anti-ragging rules and anonymous grievance reporting will be made more accessible
  - d) Hostel Staff are once again sanitized via meetings and posters
  - e) The Anti-RAGGING Squad's round the clock surveillance is further strengthened, The Faculty, Wardens and Hospital Staff directed to intensify monitoring and mentoring.

In its concluding remarks, the Anti-Ragging Committee remains fully committed to maintain a ragging free campus culture in Swami Vivekanand Subharti University, Meerut inspired by ethical values of Shiksha, Sewa, Sanskar and Rashtriyata as envisioned by the Founder of the University.
