Terms of Reference:

1. The Finance Committee shall meet at least, twice in every year. The quorum for a meeting of the committee shall be three. All nominated members of the committee, other than ex-officio members shall hold office for a term of five years and shall be eligible for a second consecutive term.
2. The committee shall consider the fee fixation proposals on the basis of the norms, as prescribed in Ordinance and shall hold as many meetings as needed. The committee shall decide tuition fees, development fees, other fees and charges for various courses or programmes, at least six months before the commencement of academic year.
3. The Fee Fixation Committee shall decide the tuition fees, development fees, other fees and charges for various courses or programmes of under-graduate and post-graduate courses or programmes run by the university) as recommended by the Academic Council at least six months before the commencement of academic year and recommend it to the Executive Council for approval.
4. The fees to be charged shall have two broad categories, namely, tuition fee and development fee. The tuition fee shall be to meet the actual cost of imparting education.
5. While assessing a fair tuition, fee, the Committee shall take into account the following, namely :-
 - a. Salary and allowances including bonus, if admissible, payable to teaching and non-teaching employees;
 - b. Expenditure on administrative services;
 - c. Cost of maintenance of laboratories including consumables;
 - d. Contingent expenditure including statutory requirements like audit fee, and the like;
 - e. Cost of acquisition of books and journals for libraries;

This issues with the approval of the Competent Authority of the University.
