






(B) That the SECOND PARTY will pay 40% of the fee deposited i.e. Rs. 8,900/- in 1st and 2nd semester each, and Rs. 11,900/- in 3rd, 4th and Rs. 10,400/- in 5th 6th, 7th 8th semester each to the FIRST PARTY as early as possible after submission of fee by the students, however, not later than one month.

BFA (Painting)--- 4 Year
