This agreement is made and entered into at Meerut on 01-05-2017

BY AND BETWEEN

Astitva Education Trust, 5, Aurbindo Marg, South Apartment, 1st Floor, New Delhi- 16
(IVS School of Design) hereinafter referred to as the "FIRST PARTY".

AND

Swami Vivekanand Subharti University located at subhartipuram, N.H. 58, Meerut
hereinafter referred to as the "SECOND PARTY".

"Astitva Education Trust" and "Subharti University" are collectively referred to as the
"Parties" and to any of them singly as "Party".

Both the parties promise to abide by the following terms and conditions :-

1. That the FIRST PARTY is a leading Institute in the field of Fine Arts located in Preet Vihar, New Delhi.
2. That the SECOND PARTY is a University named as Swami Vivekanand Subharti University situated in NCR region on Delhi-Hardiwar Highway, NH-58, Subhartipuram, Meerut (UP).
3. That the FIRST PARTY will act as an industrial collaborative partner of the SECOND PARTY.
4. That the FIRST PARTY is doing an alliance with SECOND PARTY to train the students of the SECOND PARTY within the campus of SECOND PARTY in the field of Fine Arts
5. That the FIRST PARTY will provide industrial training to the students of SECOND PARTY. Teaching staff and other requisite infrastructure will be provided by the FIRST PARTY at its own cost for imparting the training.

6. That the FIRST PARTY would help the SECOND PARTY to generate admissions of the students for Four year degree course of B.F.A.(Bachelor of Fine Arts) to its maximum ability.
7. That the students will deposit their full prescribed fee with SECOND PARTY as given hereunder:

- 2nd Semester : Rs. 22,300/- (Total 1st sem & 2nd sem = Rs 44,600/-)

Painting

- 3rd Semester : Rs. 25,500/-
- 4th Semester : Rs. 25,500/- (Total 3rd sem & 4th sem = Rs 51,000/-)
- 5th Semester : Rs. 22,500/-
- 6th Semester : Rs. 22,500/- (Total 5th sem & 6th sem = Rs 45,000/-)
- 7th Semester : Rs. 22,500/-
- 8th Semester : Rs. 22,500/- (Total 7th sem & 8th sem = Rs 45,000/-)

Applied Art

- 3rd Semester : Rs. 27,000/-
- 4th Semester : Rs. 27,000/- (Total 3rd sem & 4th sem = Rs 54,000/-)
- 5th Semester : Rs. 24,000/-
- 6th Semester : Rs. 24,000/- (Total 5th sem & 6th sem = Rs 48,000/-)
- 7th Semester : Rs. 24,000/-
- 8th Semester : Rs. 24,000/- (Total 7th sem & 8th sem = Rs 48,000/-)

Sculpture

- 3rd Semester : Rs. 22,500/-
- 4th Semester : Rs. 22,500/- (Total 3rd sem & 4th sem = Rs 45,000/-)
- 5th Semester : Rs. 19,500/-
- 6th Semester : Rs. 19,500/- (Total 5th sem & 6th sem = Rs 39,000/-)
- 7th Semester : Rs. 19,500/-
- 8th Semester : Rs. 19,500/- (Total 7th sem & 8th sem = Rs 39,000/-)

8. That the students will pay Rs.1500/- as Registration Fee in addition to the fee as per Clause No.7 above and submit their admission forms and relevant documents as per the University schedule.
9. That any other charges including fee for re-examination (supplementary), in addition to the regular fee, will be paid by the students to the SECOND PARTY as per University rules wherever applicable.
10. In case of withdrawal of admission, the existing rules of the University will apply.
11. That the SECOND PARTY will pay 65% of the fee deposited i.e. Rs. 14495/= in 1st and 2nd semester each, Rs. 16575/= (for Painting), Rs. 17550/= (for Applied Art), Rs. 14625/= (for Sculpture) in 3rd and 4th semester each, and Rs. 14625/= (for Painting), Rs. 15600/= (for Applied Art), Rs. 12675/= (for Sculpture) in 5th & 6th, 7th & 8th semester each to the FIRST PARTY to meet its expenses as early as possible after submission of fee by the students, however, not later than one month.
12. That the contractual period is valid from 01.05.2017 to 30.04.2020.
That both the parties have an option to renew the contract after the completion of the aforesaid term. Also, both of the parties may mutually decide to discontinue the contract in between.
13. That both the parties have to abide by all the rules and regulations of the agreement.
14. That in case of any dispute, all the matters are to be subjected to the Allahabad High Court.
