MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on the 23rd of February 2023 BETWEEN

THEREFORE, THIS INDENTURE WITNESS AS UNDER

- (1) WHEREAS, **the Party of First Part** engaged in the business related to placement, skill development, spoken & written classes, personality development & professional classes with the help of multiple Companies, skill development center, education institution, human resource professionals, human resources consultant & top-level employees of various institutions & WHEREAS, **the party of Second part "SVSU"**, is a college of Uttar Pradesh seeking services from the party of the first part.
- (2) WHEREAS the Party of the First part agrees to provide internship opportunities to the aspirants mobilize by the party of the Second Part.
- (3) Whereas the party of the first part will create a separate payment link for the aspirants looking for internship (registration fees is INR 500), party of the second part will be the monitoring body for the registration process. After the payment of registration fees party of the first part will issue the LOIs to party of second part. The duration of internship will be from 6 weeks to 10 months and will be decided by mutual consent of both parties.






- (4) WHEREAS after the successful completion of internships party of the first part will ensure that corresponding certificates will be provided to the aspirants of party of the second part by the companies.

- (10) WHEREAS, if both the parties mutually agreed to make the amendment, modification, or alteration in the present agreement if required.
