## Memorandum of Understanding

Between

**Lakshmibai National Institute of Physical Education,**

**Gwalior (MP) INDIA**

and

**Swami Vivekanand Subharti University, Meerut, Uttar Pradesh, INDIA**



### INTRODUCTION

The purpose of this agreement is to establish a basis for operating the Collaboration between **Swami Vivekanand Subharti University (SVSU), Meerut (UP)**, the first party and the second party **Lakshmibai National Institute of Physical Education, Gwalior (MP) INDIA** on 9<sup>th</sup> March 2022.

And

Whereas, Swami Vivekanand Subharti University (SVSU), established on 5<sup>th</sup> September 2008 by Legislative Council of Uttar Pradesh, located in Meerut (U.P.), India has number of faculties namely, Arts & Social Sciences, Dental Sciences, Education, Physical Education, Engineering & Technology, Journalism & Mass Communication, Law, Library Sciences, Management & Commerce, Medicine, Physiotherapy & Allied Health Science, Pharmacy, Science, Nursing, Fine Arts and AYUSH.

And

Whereas, both Universities are desirous to establish a program for academic cooperation in the areas of mutual interest and in accordance with the terms and conditions set out in this agreement.

### OBJECTIVES

The purpose of this Agreement is to establish partnerships to further mutual interests and to foster and develop cooperation between the two Universities and agree;

- (a) To exchange on reciprocal basis, students at Undergraduate & Post Graduate levels for limited period of time for purpose of education, training and research.
- (b) To exchange faculty for a limited period for academic exposure and interaction.
- (c) To exchange information on research and educational programs.

- (d) To exchange students for internship between both the Universities.
- (e) To institute Dual Degree programs in those subjects where considered feasible subject to the approval of statutory bodies of both the Universities and prevailing laws of the Countries.
- (f) Mutual Online working.

The terms of Partnership will be as under:

a) **Student/Residents Exchange Program:**

Few selected Students/interns/Residents from Swami Vivekanand Subharti University will be sent to **Lakshmibai National Institute of Physical Education, Gwalior (MP), INDIA** for a short period and similarly few Interns/Residents of **Lakshmibai National Institute of Physical Education, Gwalior (MP) INDIA** will be sent to Swami Vivekanand Subharti University for participating in academic programs at their level. No tuition/training fee shall be charged for the participants. The participants will bear their travel cost. Their boarding and lodging will be arranged by the host Universities on subsidized payment to be paid by the participants.

b) **Faculty Exchange Program:**

Selected Faculty of one University will visit to the other University for a prefixed short term or take up fixed term visiting assignment at each other's institution. The University will bear their travel cost. Their boarding and lodging will be arranged by the host University on subsidized payment to be made by the participants and the expenses made by participant faculty will reimbursed by parent University.

c) **Research Collaboration:**


SVSU and LNIPE will exchange information on research programs and will encourage and provide facilities to research fellow desirous of undertaking a research project at their own or the partner's University on the basis of mutually agreed arrangements. However both the Universities will ensure that the Intellectual property rights of the owner are not infringed upon.

d) **Dual Degree Program:**

Taking into account the statutory provision in the country, the SVSU and LNIPE will explore the possibility of transfer of the credits for the students, who wish to pursue a part of their course at the other University. In such cases dual degree will be given to the students.

- e) Both Universities will appoint 1 representative from each side as Nodal Officer who will discuss and sort out issues related to their agreement to taken up.

### DURATION OF AGREEMENT

This agreement will take effect from the date of signature by the representatives of the two Universities and will remain effective for a period of five years, which may be considered for renewal on completion of the period.

### TERMINATION OF AGREEMENT

Both parties have option of terminating this agreement by giving notice of one year while assuring in full that no hardship will be faced by the students already in the pipeline of the program.






