

AGREEMENT

This agreement is made and executed at Meerut on on **19th August, 2020** between .Advanced Educare Training Private Limited (AET) through its Managing Director, Mr. Sangram Mohanty S/o Sh. Subodh Chandra Mohanty, located at Office No-204/203, Arrow Corporate Tower, Plot No-6, Sector-14, Kaushambi , Ghaziabad , UP, Pin-201010 hereinafter referred to as the "FIRST PARTY".

AND

Swami Vivekanand Subharti University through its Registrar Mr. D.K.Saxena S/o late G.P.Saxena located at Subhartipuram, N.H. 58, Meerut hereinafter referred to as the "SECOND PARTY".

".AET." and "Subharti University" are collectively referred to as the "Parties" and to any of them singly as "Party".

Both the parties promise to abide by the following terms and conditions:-

1. That the FIRST PARTY run a leading Institute & one Animation Studio in the field of Animation located in Meerut.
2. That the SECOND PARTY is a University named as Swami Vivekanand Subharti University situated in NCR region on Delhi-Hardiwar Highway, NH-58, Subhartipuram, Meerut (UP).
3. That the FIRST PARTY will act as an industrial collaborative partner of the SECOND PARTY.
4. That the FIRST PARTY is doing an alliance with SECOND PARTY to impart practical training in the field of Animation students of the SECOND PARTY, within the campus of SECOND PARTY
5. That the FIRST PARTY will provide industrial exposure to the students of SECOND PARTY. Teaching staff and other requisite infrastructure will be provided by the FIRST PARTY at its own cost for imparting the industrial exposure.
6. That the FIRST PARTY would facilitate SECOND PARTY to generate admissions of the students to its maximum ability for –
 - a. 3 year degree course of B.Sc. Animation
 - b. 2 year master degree course of M.Sc. Animation

7. That the students will deposit their full prescribed fee as per prospectus and/or fee decided and informed by second party through official communication. However, for convenience fee for the session 2020-21 is given hereunder:

8. That the SECOND PARTY will pay 40% of the Professional training fee from fee deposited by student i.e. in case of academic year 2020-21 **B.Sc. Animation 13200/- per semester** in 1st and 2nd semester, and **11,500/- per semester** in 3rd, 4th, 5th & 6th semester and whereas in case of **M. Sc - Animation 12,300/- per semester** in 1st and 2nd semester each, and **10,100/- per semester** in 3rd, 4th each to the FIRST PARTY. This Professional training fee will be paid as early as possible after submission of fee by the students.
9. That the students will pay **Rs.1500/- as Registration Fee** in addition to the fee as per Clause No.7 above and submit their admission forms with requisite documents as per the University rules.
10. That any other charges of SECOND PARTY including fee for **re-examination (supplementary), Migration Fee, Degree Fee etc.** in addition to the regular fee, will be paid by the students to the SECOND PARTY as per University rules wherever applicable.
11. In case of withdrawal of admission, individual case will be processed based on the rules of the SECOND PARTY (University).
12. SECOND PARTY will provide fee details every year before commencement of Academic Year.
13. Caution Money/ refundable security fee shall not be applicable for the students taking admission based on this MOU.
14. If "first Party" facilitates successful Professional training based on parameters set by University to Second party students; Second party will pay their training fee as per table below:-

15. That the contractual period is valid from **Academic Year 2020-21 for six years.**
(So 2 batches of B.Sc. and 3 Batches of M.Sc. will complete together).
16. The fee will be subject to change every year as per the prospectus of the second party.
17. That both the parties have an option to renew the contract after the completion of the aforesaid or mutually agreed term(s).
18. That both the parties have to abide by all the rules and regulations of the agreement.
19. That in case of any dispute, all the matters are to be subjected to the Civil Court at Meerut.
