## INTRODUCTION

The purpose of this agreement is to establish a basis for operating the Collaboration between Five Lotus Indo-German Nature Cure Centre, Raipur, Chhattisgarh the first party, and Swami Vivekanand Subharti University (SVSU), Meerut (UP) the second party in the field of Naturopathy & Yogic Sciences on May 2024

**And**

Whereas, Swami Vivekanand Subharti University (SVSU), established on 5<sup>th</sup> September 2008 by Legislative Council of Uttar Pradesh, located in Meerut (U.P.), India has number of faculties namely, Arts & Social Sciences, Dental Sciences, Education, Engineering & Technology, Journalism & Mass Communication, Law, Management & Commerce, Medicine, Physiotherapy & Allied Health Science, Pharmacy, Science, Nursing, Fine Arts and AYUSH.

**And**

Whereas, both Universities/ organizations are desirous to establish a program for academic cooperation in the areas of mutual interest and in accordance with the terms and conditions set out in this agreement.

## OBJECTIVES

The purpose of this Agreement is to establish partnerships to further mutual interests and to foster and develop cooperation between the two Universities/ organizations and agree:

- a) To exchange on reciprocal basis, students at Undergraduate & Post Graduate levels for limited period of time for purpose of education, training and research.
- b) To exchange faculty for a limited period for academic exposure and interaction.
- c) To exchange information on research and educational programs.
- d) Mutual Online working.

The terms of the Partnership will be as under:

**Student/Residents Exchange Program:** A few selected Students/interns/Residents from Swami Vivekanand Subharti University will be sent to Five Lotus Indo-German Nature Cure Centre, Raipur, Chhattisgarh for a short period. No tuition/training fee or accommodation shall be charged for the participants. The participants will bear their travel costs. Their boarding and lodging will be arranged by the host. No stipend or any kind of payment will be paid to the participants for their services.



Both Universities/ Organizations will appoint one representative from each side as Nodal Officer who will discuss and sort out issues related to their agreement to be taken up.

**DURATION OF AGREEMENT**

This agreement will take effect from the date of signature by the representatives of Both Universities/ Organizations and will remain effective for a period of five years, which may be considered for renewal on completion of the period.

**TERMINATION OF AGREEMENT**

Both parties have the option of terminating this agreement by giving notice of one year while assuring in full that no hardship will be faced by the students already in the pipeline of the program.
