

This Memorandum of Understanding ("MOU") is made in Jodhpur on the 05 July' 2024.

By and between

M/s. NPrep EDTECH PRIVATE LIMITED, a company incorporated under the Companies Act, 1956 having its office at B76 Zone 1, Vyapar Vihar, Bilaspur, Chhattisgarh, India. represented by its Founder Dr. Prince Kaushik as its authorised signatory hereinafter referred to as NPrep.

AND

SUBHARTI UNIVERSITY having its registered office at Subhartipuram, NH 58 Delhi Haridwar Bypass Road, Meerut - 250005, India, hereinafter referred to as "The Institution" which expression, unless repugnant to the context or meaning thereof, shall mean and include its successors permitted assigns and affiliates and represented by its Registrar, as its authorised signatory.

NPrep and The Institution shall hereinafter be collectively referred to as "Parties" and individually as a "Party".

NPrep is interested in providing educational resources which includes but is not limited to video lectures, notes, mock tests and Qbank for preparation of the competitive exams after nursing graduation to all the nursing students of the university, along with hands-on workshop and seminars for the nursing students

The Institution is therefore interested in associating with NPrep to offer these services. NPrep has agreed to the same subject to certain terms and conditions mutually agreed between the Parties.

The Parties are desirous of recording the terms of the collaboration agreed to between them.

NOW, THEREFORE, in consideration of the mutual understandings and agreements set forth herein, the Parties hereto hereby agree as follows:

#### 1. TERM

This MoU shall come into effect on this date and shall be valid for a period of 5 years ("Initial Term") unless otherwise extended in writing by the Parties or terminated in accordance with the terms hereof.

4.9. The Institution shall select a date for the seminars and workshop.

4.10. The Institution shall distribute the progress report to the students on receipt of the same from NPrep.

## 5. COMMERCIAL TERMS

5.1. The course fees for the various levels are listed in Annexure II and will be applicable for each academic year.

## 6. PAYMENT TERMS

6.1. The course fees shall be paid semester wise in two instalments for the onboarding year. The renewal fee shall be paid in a single instalment at the end of onboarding year.

6.1.2. The course fees can be made directly to NPrep's Bank Account.

## 7. CONFIDENTIALITY

7.1 Each Party shall keep confidential and shall not without the prior consent in writing of the disclosing Party copy or disclose to any third party the content of any documents or information (whether of a commercial, financial or technical nature or which is identified as being confidential) acquired or received in writing, orally or in any other tangible or intangible form from the other Party in connection with this MoU, such information referred to as "Confidential Information".

## 8. EMPLOYMENT

8.1. The Institution shall not take into employment on a full time or part time, any of NPrep employees for 3 years from the end of this MoU.

## 9. TERMINATION

9.1. This MOU may be terminated:

9.1.1. By unanimous consent after clearing all pending dues on either side.

9.1.2. In the event of any lawful authority ordering the Parties to terminate this MOU

## 10. APPLICABLE LAW AND ARBITRATION

10.1. This Agreement shall be governed by Indian law.

10.2. Any dispute arising out of or in connection with this MoU, including any question regarding its existence, validity or termination, shall be referred to and finally resolved by arbitration at Bilaspur, India in accordance with the Indian Arbitration and Conciliation Act, 1996. The arbitration shall be conducted by three (3) arbitrators with each Party appointing an arbitrator and the two arbitrators so appointed appointing the third and presiding arbitrator. The language of the arbitration shall be English.

## 2. GRANT OF RIGHTS

3.7. NPrep shall be responsible for the complete organisation and conduct of the annual workshop (minimum 150 students required) and quarterly seminars for enrolled students

## 4. OBLIGATIONS OF THE INSTITUTION

4.1. The Institution agrees in creating awareness amongst the students studying in nursing college about the importance of preparing for competitive exams while in the graduation course.

4.4. The Institution shall share the details of the students in the format given by NPrep for creation of login credentials.
