This agreement is made and entered into at Meerut on 05/07/2022

BY AND BETWEEN


3. That the FIRST PARTY will act as an industrial collaborative partner of the SECOND PARTY.

6. The SECOND PARTY will provide to the FIRST PARTY, Syllabus for 1st Year, 2nd Year, 3rd Year for B.Sc. and M.Sc. (Interior Designing), MFD (Fashion Design), B.Sc. (Textile Design), Syllabus for 1st year, 2nd year, 3rd year and 4th year in BFA Fashion Design will provide.
7. That the FIRST PARTY would help the SECOND PARTY to generate admissions of the students for 2/3/4-year Degree and Master Degree Course of B.Sc., M.Sc. (Interior Design), B.Sc. (Textile Design), MFD (Fashion Design) and BFA (Fashion Design) to its maximum ability.
8. That the students will deposit their full prescribed fee with SECOND PARTY as given hereunde

- 3rd Semester : Rs. 29,000/-
- 4th Semester : Rs. 20,000/- (Total 3rd sem & 4th sem = Rs 49,000/-)

9. That the students will pay Rs.1500/- as Registration Fee in addition to the fee as per Clause No. 8 above and submit their admission forms and relevant documents as per the University schedule.
10. That any other charges including fee for re-examination (supplementary), in addition to the regular fee, will be paid by the students to the SECOND PARTY as per University rules wherever applicable.

11. BFA (Fashion Design)--- 4 Year

- (A) That the SECOND PARTY will pay 40% of the fee deposited i.e. Rs. 10,800/- & 7000/- in 1st and 2nd semester each, and Rs. 15,400/- & 8,400/- in 3rd, 4th and Rs. 12,400/- & 8,400/- 5th & 6th, and Rs. 12,400/- & 8,400/- 7th 8th semester each to the FIRST PARTY as early as possible after submission of fee by the students, however, not later than one month

B.Sc (Interior Design)--- 3 Year


- (B) That the SECOND PARTY will pay 40% of the fee deposited i.e. Rs. 16,400/- & 10,000/- in 1st and 2nd semester each, and Rs.13,000/- & 10,000/- in 3rd, 4th and Rs. 13,000/- & 10,000/- 5th & 6th semester each to the FIRST PARTY as early as possible after submission of fee by the students, however, not later than one month.

B.Sc (Textile Design)--- 3 Year

- (C) That the SECOND PARTY will pay 40% of the fee deposited i.e. Rs. 14,400/- & 9,000/- in 1st and 2nd semester each, and Rs.11,400/- & 9,000/- in 3rd, 4th and Rs. 11,400/- & 9,000/- 5th & 6th semester each to the FIRST PARTY as early as possible after submission of fee by the students, however, not later than one month.

MFD (Fashion Design) -- 2 year

- (D) That the SECOND PARTY will pay 40% of the fee deposited i.e. Rs. 15,000/- & 8,000/- in 1st and 2nd semester each, and Rs 11,600/- & 8,000/- in 3rd, & 4th semester each, to the FIRST PARTY as early as possible after submission of fee by the students, however, not later than one month.



M.Sc (Interior Design) -- 2 year

(E) That the SECOND PARTY will pay 40% of the fee deposited i.e. Rs. 15,000/- & 8,000/- in 1st and 2nd semester each, and Rs 11,600/- & 8,000/- in 3rd, & 4th semester each, to the FIRST PARTY as early as possible after submission of fee by the students, however, not later than one month.

12. That the Agreement Term period is valid from 01/08/2022 to 31/07/2026
13. If the First Party gives above 100 admissions then the fee sharing ratio will be 50:50, if the First Party give below 100 admissions, the ratio will be 60:40.
14. That both the parties have an option to renew the contract after the completion of theaforesaid term.
15. That the first party can use the LOGO and NAME of Second Party in its promotional activities and on various platforms as industrial collaboration partners.
16. That both the parties must abide by all the terms and conditions of the agreement.
17. That in case of any dispute, all the matters are to be subjected to the Allahabad HighCourt.




