**FEE STRUCTURE AND OTHER IMPORTANT TERMS AND**  
**CONDITIONS FOR ADMISSION IN ACADEMIC SESSION 2018-19 IN**  
**M.D.S. COURSES**

1. **FEE FOR PG COURSES:**

**A. (i)** The fee decided by the Government vide their letter NO. 239/71-4-18-37/2015 dated 31-03-2018, is as mentioned below:

<b>Tuition Fee</b>
Rs. 4,33,000/- per year

(ii) The fee decided as mentioned in table above is ex-parte, arbitrary & illegal. The issue of fee of post graduate courses is already under consideration of the Hon'ble Supreme Court in **SLP no. (C) 721/2018**. Therefore, the fee decided by the Government is **provisional and is subject to change** in accordance with the orders of the Hon'ble Supreme Court. A separate Writ may also be filled against the order of the Government dated 31-03-2018.

(iii) Since, the matter is under consideration of the Hon'ble Court, the above **fee is liable to change**, therefore, the students who will be given admission on the basis of the above said fee, will have to give **a registered undertaking** that they will pay the fee as decided by the Hon'ble Court or by the Government/the University under directions from the Hon'ble Court.

**B. (i)** The University has decided the fee structure for the PG courses, which is as below:

(a)	Orthodontics and Dentofacial Orthopedics Oral & Maxillofacial Surgery Conservative Dentistry & Endodontics Prosthodontics and Crown Crown & Bridge	Rs. 7,50,000/- per year.
(b)	Pediatrics and Preventive Dentistry	Rs. 7,00,000/- per year.
	Periodontology	Rs. 6,00,000/- per year
(c)	Oral Medicine & Radiology	Rs. 4,00,000/- per year.
(d)	Oral & Maxillofacial Pathology & Oral Microbiology	Rs. 2,75,000/- per year

**(ii)** The students who decide to follow the above fee structure will be required to give an undertaking that they have voluntarily accepted the above fee structure without any pressure or coercion. **Such students shall be indemnified by the**

**college from any change in fee which may take place as a result of decision by the Hon'ble Court, therefore, will not be required to give any registered undertaking as mentioned in point no. 1 (A) (iii) herein above.**

2. General instructions:

(i) Full Fee will be required to be deposited before the LAST DATE declared by the Government / Counseling Board. **No Part Payment** of Fee is permitted.

(ii) Refundable security deposit:

will be Rs. 5,00,000/- (Five Lacs) for the departments of Pediatrics and Preventive Dentistry, Orthodontics and Dentofacial Orthopedics, Oral & Maxillofacial Surgery, Conservative Dentistry & Endodontics, Prosthodontics and Crown & Bridge, Periodontology, Oral Medicine & Radiology and Oral & Maxillofacial Pathology & Oral Microbiology.

(iii) An additional training, supplementary exam's fee from failed/detained students will be charged, which will be as per the decision of the Executive Council of the University.

4. Hostel is compulsory for the P.G. students of all Departments except department of Oral Pathology & Oral Medicine & Radiology.

5. Hostel & Mess charges will be extra which will be Rs. 90,000/- per year to 4 lacs per year depending upon the facilities availed by the students.

6. Refundable Hostel Security – Rs. 50,000/-.

**Note: i) Fee once deposited is non-refundable.**

**ii) Any condition can be relaxed or waived off by the Hon'ble V.C. in genuine cases on being applied by the student.**

**iii) Special consideration shall be given to the students who have passed BDS from Subharti Dental College on being applied for.**
