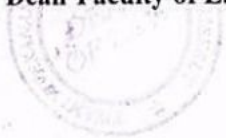

**Event- Value Added Course on Goods and Services Tax**


**Date- 30-10-2018 to 30-11-2018**
