

I. **Background of the Institution**

**INTRODUCTION**

Swami Vivekanand Subharti University, Meerut (hereinafter referred to as the University or SVS University) was established by Government of Uttar Pradesh under the ~~Swami~~ Swami Vivekanand Subharti Vishwavidyala Uttar Pradesh Adhiniyam, 2008 (UP Act No.29 of 2008) (hereinafter referred to as the Act, copy placed at **Annexure-1**) as passed by the Uttar Pradesh Legislature and assented to by the Hon'ble Governor of Uttar Pradesh on September 04, 2008. On getting authorization from the Government of Uttar Pradesh (copy at **Annexure-2**), the University started functioning with effect from 15<sup>th</sup> September, 2008. The University has been recognized by the University Grants Commission under Section 2 (f) of the UGC Act, 1956. The SVS University has the unique distinction of being the only Private University in the area of the district of Meerut to disseminate higher education (conventional, academic and professional) for the students of this region. The SVS University is situated in 100 acres premises on the National Highway 58 in the National Capital Region just 60 kms. from Delhi.


