Agenda 2: Effort to sustain and improve inputs on Teaching - Learning and Research.

Resolution: The Chairperson of IQAC invigorated all the members present to aim for A++ in NAAC.

Point wise discussion was done in the first three criterions of the NAAC Manual.

- BOS and Academic Council meetings and their minutes to be filed year wise.
- Syllabus should be modified as per Industry requirement and Employability.
- Add on courses to be introduced and provide greater academic flexibility.
- Feedback system should be on website.
- Six week induction program to be introduced and bridge courses for slow learner.
- Faculty members to upload their lectures on local management system (LMS).
- Clinical psychologist to take lecture in each institution for fostering emotional growth.
- Percentage of full time teachers with Ph.D should be above 33%.
- Focus on outcome based education and outcome based assessment.
- Code of ethics to be put on website.
- Student participation in committees and boards to be enhanced.
- Motivate at least 80-85% students to participate in extension activities.
- University should develop interface linkage with industries for better placement. Coaching of the student for NET, SLET/GATE etc. to be arranged and to promote placement opportunity.
- We need to encourage students and faculty members to use Central Library.
- Research work, Innovation and patents are negligible. They need to be strengthened.
- Create a web-link of IQAC on the website.

It was also discussed that the projected future plans as incorporated in the SSR to be implemented/completed.
