

# Report of Workshop on QS Academic and Employer Reputation Surveys

## 1. Introduction

An awareness workshop on the QS World University Rankings was organised by the Internal Quality Assurance Cell (IQAC) to sensitise faculty members, College Representatives, and Alumni Coordinators about the QS ranking framework, with particular emphasis on the **Academic Reputation Survey and Employer Reputation Survey**. The workshop aimed to strengthen institutional understanding and coordination specifically with respect to the QS reputation survey processes.

- Role of College Representatives and Alumni Coordinators in QS data submission


## **Methodology**

The workshop was conducted through a structured **PowerPoint presentation**, followed by interactive discussions. Participants were encouraged to seek clarifications and share observations related to QS ranking processes and data requirements.

## **Outcomes of the Workshop**

The workshop resulted in the following outcomes:

- Participants gained clarity regarding the **University's achievements and standing in QS Rankings**.
- Enhanced awareness about the **Academic Reputation Survey and Employer Reputation Survey**, including their role in global ranking assessments.
- College Representatives and Alumni Coordinators developed a better understanding of the **QS data requirements and submission process**.
- Participants were sensitised to the importance of **timely, accurate, and verified submission of information** for QS rankings.
- It was specifically emphasised that, while sharing **alumni and employer contact details for QS reputation surveys, official email IDs (institutional or organisational email addresses) should be given priority**, wherever available, to ensure authenticity and credibility of the survey process.
- Overall, the workshop was informative and constructive, and it reinforced the importance of **systematic coordination, data accuracy, and timely information sharing** as part of the University's **continuous quality improvement efforts**, thereby strengthening its participation in the **QS Academic and Employer Reputation Surveys**.
