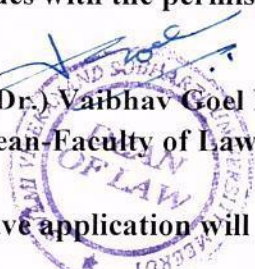

As per the direction of Director **Justice Rajesh Chandra** (Former Judge High Court Judicature Allahabad), for the same one committee has been constituted in which Prof. (Dr.) Vaibhav Goel Bhartiya asked to work as convener of syllabus review committee and Dr. Sarika Tyagi as Secretary of the same. Meanwhile University asked faculties to provide curriculum based on CBCS pattern as the same was briefed last year somewhere on 08.05.2017 while Dr. Reena Bishnoi was the Dean faculty of the law. Hence the structure of CBCS pattern which was developed from then Dean was demanded on 28.04.2018. She submitted the report on 26.05.2018. 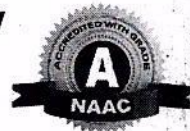



- The Meeting started with a question regarding knowledge of CBCS where all were found unaware on CBCS. Though CBCS slide have been forwarded to all the faculty members on 28th April 2018.
- Dean Faculty of Law Dr. Vaibhav Goel Bhartiya has given a brief introduction of CBCS on projector.
- Then the structure developed and submitted by Dr. Reena Bishnoi was discussed which was not found suitable and appropriate.
- Then in the meeting Dean faculty of law and introduced rough structure on CBCS pattern as per BCI guidelines for BALLB dual degree course where from humanities two minor paper, one Major Paper, English in two semester, twenty compulsory papers, four Clinical papers along with choice based electives have been designed and stretched in five years to acquire a total of 220 credits besides 5 credits in value addition courses for the attainment of the degree.
- Latter on the herculean task of syllabus development and moderation exercise scheduled from 29.05.2018 in form of the workshop. All the faculty members were found well prepared. In length discussion have been made and opinion of each member of the board have considered and on consensus decisions have been finalized. Here the opinions of the stake holders have also played pivotal role.
- Course has been bifurcated in to certain had as Law papers are divided into core subjects, Choice based elective subjects, core clinical paper and pre Law subject as language paper, major paper, minor paper along with few value added papers.
- Three paper are taken into consideration as value added that is general studies, logic and reasoning and Minor Acts.

Finalized course structure and modified syllabus and other necessary papers have been complied.

Meeting ended with Vote of thanks to all the members with special thanks to Justice Rajesh Chandra, Ms Avi Chaudhary and Ms Mahima Garg.
