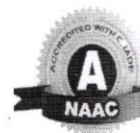

19 Discussion and Resolution: To prepare panel of external examiner for practical examination held on September 2018-19.

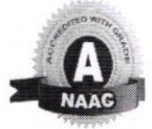

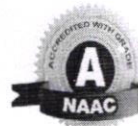


