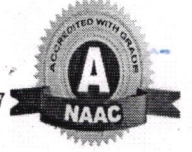

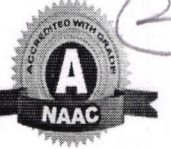

Following decision were taken in the meeting:

Since we are governed by Dental Council of India which has clearly stated the format of question papers of BDS/MDS courses, we can not change much in existing format, however, following changes have been proposed and are in practice.

BDS

- 15% of the questions are of MCQs type (10 questions of 1 mark each) which are given to the candidates in the starting of the examination on a separate sheet and taken back with in 10 – 15 minutes.
- There are 2 questions with A & B sections which are based on clinical situation (**Problem based short questions**). In this, the student has to first diagnose the case and then discuss the treatment plan.

Suggestion:

It is suggested that in part B of question paper, at least 5 very short answer type questions (BAQ) can be asked (5X2=10) eg. write dose of LA with & without adrenelin.

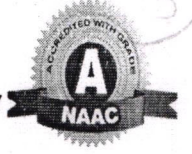

It is proposed that 1 – 2 short essay type questions can be converted in to MCQs with 1 mark each (14 MCQs X 1 = 14 Marks).

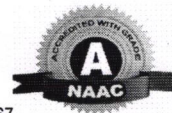
