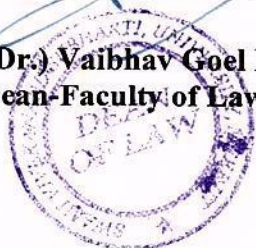

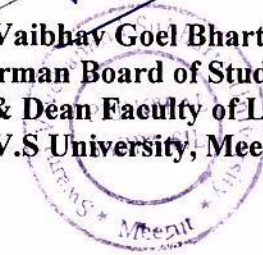

2. Relevance of LL.M. Three Years Evening Course.

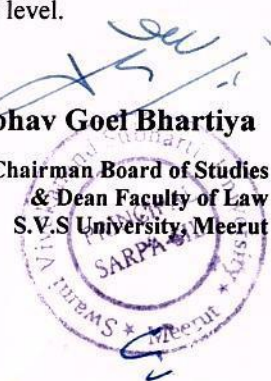
Unanimously this has been resolved that the LL.M. Three Years Evening Course should be closed w.e.f. 2017-18
