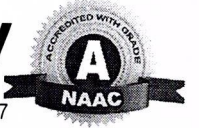

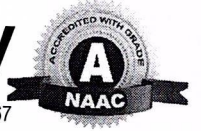

Resolution: Actions taken were noted by the members.

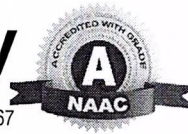
3. **Agenda Item No. 3:** To circulate annual academic calendar for session 2021-22 for Department of Neurological Physiotherapy.
