The Convener of the meeting welcomed the members and explained the agenda of the meeting with the members. Each item of the agenda was discussed at length by the committee and resolved as under:

1. The Chairperson underscored the importance of implementing the **Choice Based Credit System (CBCS) and elective courses** for M.A. English program, starting from the academic year 2021-22, in accordance with the guidelines issued by the UGC. This system is intended to offer students greater flexibility in selecting courses, ensuring the program aligns with the UGC guidelines for holistic and interdisciplinary education.
2. Dr. R.N. Sharma, the Head of the Department of Languages, provided an update on the thorough review of the existing syllabus. Following careful consideration, it was determined that the curriculum would be redesigned to incorporate a variety of elective courses, alongside the mandatory core subjects. The introduction of the CBCS framework is set to take effect from the 2021-22 academic sessions.

- The chairperson elaborated that the new structure will divide each semester into 16 credits, culminating in a total of 128 credits for the entire program. While core courses will continue to be compulsory, students will have the opportunity to select from a diverse range of elective options, such as European Comedy, Nineteenth Century Novel, and English Language & Literature Teaching. This revamped curriculum aims to broaden students' academic exposure and enhance their skills by integrating both traditional and contemporary literary studies.
