1. No change in curriculum was proposed.

- 2. HoD paramedical Sciences informed that the course of Diploma OT Technician can be started under the University from Academic session 2016-17 after approval of Hon'ble Vice Chancellor. These courses are outside the preview of UP State Medical Faculty. It is forwarded to Academic council for ratification. (Annexure No.1)
- 3. HoD paramedical Sciences proposed increase in seat of B.Sc. MLT course from 90 to 110. This program is running in Subharti Medical College since 2009 with 20 admissions per year. It was further increase to 90. It is further proposed to Hon'ble Vice Chancellor to increase admissions from 90 to 110 and was approved. The proposal is sent to Academic council for ratification. (Annexure No.2)
- 4. Dean Academics discussed about the panel of External & Internal Examiners. He proposed that the name of internal and external examiners for MBBS, MD/MS/DA and other courses should be sent separately for 2 academic years i.e. 2016-2017, 2017-18.

Proposal No. 2, 3 have been sent to Academic Council for approval.
