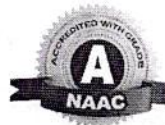

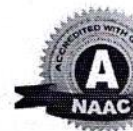

2. Item No. 2: To adopt the new curriculum for MBBS programme as prescribed by MCI

Dr. Surabhi Gupta informed all the members about the CBME based new curriculum for MBBS program introduced by MCI and is to be implemented from Aug 2019. According to this new curriculum the theory part of Pharmacology subject is divided into total 64 competencies. These competencies are further divided according to various aspects of systemic and general Pharmacology.

Dr. Surabhi Gupta advised the faculty members to write 3-4 objectives for each competency given to them. The competencies were divided amongst the faculty members in the following manner:

1. Dr. Surabhi Gupta : Miscellaneous (14)
2. Dr. H.L. Bhalla : ANS (03); CVS (6); PNS (1); Renal (1); Blood (2).
3. Dr. Saurabh Kansal : CNS (6); Respiratory System (2); Endocrinology (6).
4. Dr. Sharmendra : AMA (8); Immunity (1); Autacoids (1); GIT (1).
5. Dr. Gaurav Kapil : General Pharmacology (12).
