The Board discussed about the new CBME (Competency based Medical Education) MBBS curriculum which is proposed to be implemented by the MCI in 2019. As per this new curriculum, the subject Forensic Medicine is divided into a total of 14 major topics which are further sub-divided into 162 competencies. It was decided to divide the topics amongst the faculty members to write 3 – 4 SLO (specific learning objectives) for each given competency. The topics were allotted to the faculties as follows: -

- Topics 6 – 10 : Dr. A. K. Srivastava
- Topics 11 – 14 : Dr. Abhishek Sangal
- Topics 13 – 14 : Dr. Mukesh Kumar
