Dr. Bhim Singh could not attend the meeting due to his illness (COVID +ve) and was admitted to LNJP hospital, New Delhi.

At the onset, the Chairperson BoS welcomed all the members and following items were taken up as per agenda.

- a) **Agenda item No. 1:** -To confirm the minutes of previous BoS held on 10/12/2019.

The members confirmed and passed the minutes.

- b) **Agenda item No. 2:** - Following action were taken on minutes of Board of Studies held on 10/12/2019.

Action taken –

1. The new CBME based MBBS curriculum of Forensic Medicine was adopted in-toto and implemented successfully in MBBS 2019 Batch as decided in previous BoS held on 10/12/2019. (Annexure-1)
 2. The value-added course which started in academic session 2018-19 could not be conducted in academic sessions 2019-20 and 2020-21 due to COVID-19 pandemic.
 3. Feedback was collected and analysed.
 4. The Panel of examiners for theory and practical examinations of MBBS programme were finalized and approved. (Annexure-2)
- c) **Agenda item No.3:** - To consider and adopt any change in CBME based curriculum for MBBS programme as prescribed by NMC.
1. According to CBME, Forensic Medicine is allotted 15 hrs for lecture, 31 hrs for SGD, 05 hrs for SDL in academic session 2021-22 starting from 8th March 2021. The time-table is attached as annexure (Annexure-3).
 2. The Final Professional University Examination of Forensic Medicine will be held at the end of Academic year 2022-23 in Final Professional Part-I examinations. The total marks in the examination for both theory and practical shall be 100 marks each.

- d) **Agenda item No. 4:** -To consider starting of a new course

A New Value-Added Course “Medico –Legal issues in Emergency” is being planned to be conducted in upcoming months in 2021.


