2	To discuss the Best Practices of Law College. As per the suggestion given by the chairman quality control Prof. Dr. N.K. Ahuja.	Ideas and suggestions regarding best practices in law college were discussed among faculties and after thorough discussion it was decided unanimously that Best Practices implemented by law College is as under: 1. Imparting Legal Education as Clinical Legal Education.	To be submitted to the office of the registrar for the needful and also required to be submitted to the office of Chairman-Quality Control.
3	Analysis to find out the ways to enhance quality of teaching	It was decided unanimously that the practices of Law college has been decided that definitely all these practices will enhance the quality of teaching.	All the faculties are required to follow the best practices to enhance quality of teaching.
4	Discussion on Re-Opening of colleges	Discussion regarding re-opening of college held and after taking opinion and suggestions of all it was decided unanimously: that college should open from 01 November 2020. First year student's classes should be off line because for proper interaction with newly admitted students off line teaching is necessary. For other students it may be 50% off line and 50% online. Policy should be uniform as per the guidelines made by the university. Proper Orientation for the First Year students will be managed by Dr. Sarika Tyagi.	To be submitted to Registrar for approval.

During the meeting Dr. Sarika Tyagi Academic Coordinator regretted for delayed meeting and Chairman, BOS condoned the delay. Most of the faculties attended Lecture by Chairman, Quality Control except Ms. Shalini Goel and Dr. Prem Chandra and they failed to give satisfactory justifications. They were asked to be more attentive and sincere to avoided such situation in future
