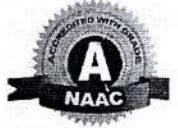



Item No. 3: Recommend Panel of Examiner to the Academic Council for U.G. program.

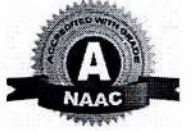

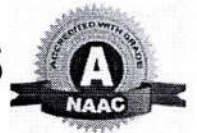
