Action taken report on previous BoS

A meeting of Board of studies was held on 15/02/2017 at 10 am in Forensic Medicine department regarding recent guidelines of Medical Council of India with respect to improvement in Undergraduate & Postgraduate teaching during MBBS & M.D. Different issues were discussed and certain points for improvement in UG & PG teaching were decided as follows:-

1. The board members opined that though the curriculum of Forensic Medicine (MBBS & M.D.) as a whole is governed by MCI as per Graduate Medical Regulations 2000, but in lieu of judgement by Hon. Supreme Court dated 1/6/2007, it is proposed that to pass a professional exam student must obtain minimum 50% marks in theory and minimum 50% marks in practicals as well.
2. The curriculum of Forensic Medicine (M.D.) has no change but as per Supreme Court guidelines, the student must obtain minimum 50% marks in theory as well as in practical.
3. The panel of examiners (MBBS & MD) were also discussed and approved by the board members.
4. The members also agreed to the introduction of MCQ in semester as well as University examinations, being made compulsory by MCI in MBBS programme.
5. Teachers were instructed to guide the students and motivate them to prepare for their upcoming exams.
6. Teachers were also instructed to discuss and solve the upcoming problems faced by the students.
