### **33(3)-Implementation of the IKS guidelines for training of faculty under Malviya Mission.**

The National Education Policy 2020 lays emphasis on the promotion of Indian Languages, Arts and Culture and tries to remove this discontinuity in the flow of Indian Knowledge System by integrating IKS into curriculum at all levels of education. In order to facilitate a seamless integration of Indian traditional knowledge with modern subjects, UGC has come up with "Guidelines for Training of Faculty on IKS". These guidelines will inspire the faculty in higher education institution of the country to generate a positive attitude, explore, and undertake

quality research on IKS, and herald a new era in higher education ecosystem of the country in the light of NEP-2020. The IKS guidelines will be a part of the training The IKS guidelines will be a part of the training modules under “Malviya Mission” This matter was discussed by council members and following points were brought out during the discussion;

- a. Dr. Anoj Raj, HOD-Department of education and Dr. Manoj Kumar Tripathi, HOD-Liberal Arts & Humanities have attended Indian Knowledge System training programme at Varanasi from 28.08.2023 to 02.09.2023 under Pt. Malviya Mission.
- b. Prof. (Dr.) Prakash Kumar Dubey, Member (External) suggested that we should try to implement the same in our AYUSH curriculum.
- c. Principal-SDC told that they have already it in their curriculum.
- d. Dr. Surbhi Gupta, Professor & Head, Pharmacology, SMC told that the yoga classes are already going on in SMC. It has been incorporated in their curriculum AYURVEDA in Community Medicine.
- e. Rashtra Bodh-subject compulsory for all students across the disciplines has IKS as part of its syllabus.

The Council resolved and accepted the following for implementation:

- a. Dr. Manoj Kumar Tripathi was directed to incorporate the Indian Knowledge System syllabus in our existing syllabus.
- b. Dean- Academics was directed to constitute a committee of faculty members and see the possibility of small courses like Temple Architecture, Ayurveda in Medical, Indian Judiciary in Faculty of Law and Mathematics in Faculty of Science. Dr. Anoj Kumar and Dr. Manoj Kumar Tripathi were directed to help in the same. It should be part of syllabus. Dean Faculty of Law shared that he has forwarded the legal issues from ancient Indian knowledge system which may be in the UG/PG curriculum are already in both the programs i.e. Minansa rules which are covered in BL-801 and ML-202.
- c. Implementation of “Rashtra Bodh” is to be taken on priority by all Faculties. Faculty of AYUSH has been entrusting with the responsibility to Co-ordinate with other faculties.

The council discussed the increase of Intake Post-graduate seats in Departments of Medicine, Surgery, Obstetrics & Gynaecology, Orthopaedics, Paediatrics, ENT, Dermatology, Psychiatry, Respiratory Medicine, Anaesthesia and Radiodiagnosis. In General Medicine increase of seats from 12 to 26, Paediatrics from 3 to 9, Obstetrics & Gynaecology from 4 to 9, Oto-Rhino- laryngology from 2 to 6, Orthopedics from 5 to 10, Radio-Diagnosis from 5 to 15, anaesthesia from 10 to 19, respiratory medicine from 2 to 6, psychiatry from 3 to 6, surgery from 15 to 19, and dermatology from 3 to 6. Starting postgraduate and super specialization in Radiotherapy with intake of 4, Neuro Surgery of 4, Cardiology of 4.

The Council resolved and ratified the increase of intake in post-graduate seats in Faculty of Medicine from academic session 2024-25 and recommended for ratification by the Executive Council.

The council discussed the existing system of Mentor Mentee System in Medical College. The existing system has inherent difficulties in its implementation. In the existing system, mentees are allotted to mentor for duration of 5 years. When the students reach their final year they do not respond the teachers of first year or second year and first year students find it difficult to locate their mentors in hospital. It is proposed that a Mentor should be made from the professional in which students are currently studying so that under new system it will be convenient for mentors to meet their Mentees and keep a track record of their academics & attendance. The mentor mentee booklets will be handed over to next mentor via Principal Office.

The Council resolved that the revision in Mentor Mentee System in medical college be accepted for implementation.

1. Citations and references for solely medical matters should follow the Vancouver style.
2. Candidates with an M.D. or M.S. degree will need to complete two years of training for the Ph.D., while those with a M.Sc. (Medical Subjects) would need to complete three years.
3. Candidates with an M.D. or M.S. degree, who have passed the BCBR will not need to take the course work test.

Dean-Academics suggested that; every faculty should prepare their drafts, we should follow the UGC guidelines and the scholar who have 3 years' experience, should be included the course work.

1. Dr. Surabhi Gupta, Professor & HOD- Pharmacology, SMC told that NCrf is clearly written that if a students has 3 years PG, one year to be adjusted in Ph.D.
2. Prof. (Dr) Prakash K. Dubey conveyed that as per NMC, Ph.D. is for 2 years and as per UGC, Ph.D. is for 3 years.

The Council resolved that the Dean Academics & Director Research to study the proposal and bring about necessary clarification on the subject. Based on clarification from Regulatory authorities, the revised proposal may be put up to next Academic Council.

We should show the copy if the result is declared to the student based on that marks are given. Both copies should be shown. Prof.(Dr.) Prakash K. Dubey told that we do not allow to show copy to the student. Student can ask for retotaling of marks only. It is discretion of Hon'ble Vice Chancellor to take decision whether copy should be shown or not to the student. COE told that if the result if declared and student after seeing the copy can say that his/her numbers are not matching. He can say that the decision of UFM committee is wrong. It should be added in the Examination Policy. It should be in writing that which is allowed to show and which is not. Hon'ble Vice Chancellor suggested that the UFM Policy should be modified as per the UGC guidelines the recommendation was accepted.
