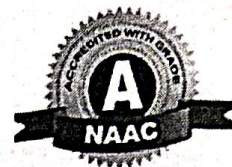





The link for checking the Web of Science, UGC-CARE, and Scopus should be shared with faculties so that they can check themselves.
2. Few faculties and scholars are not aware of how to publish a quality research paper in Scopus, WOS, or UGC CARE and publication strategies for fast processing, so conducting various lectures on the same at the college level should be organized.
3. As per discussion, we should focus on quality research and publication.
4. It is mandatory to create and update the profiles of VIDWAN, Google Scholar, ABACUS- UP, etc.
5. The primary data and secondary data should be managed by faculties, and if faculties are facing any problems for experiments, they can use the central facilities of our university.
University is promoting maximum utilization of Research facilities of internal resources (including equipment and technology); if a faculty member is willing to use any facility of the university, they can send an email request through CRC to STEM and STEM to URCAB for utilization of facilities.
